Agreement

- The "new owner" will enter their name in the pet's passport.
- The "new owner" will register the microchip number of "the adopted pet" in their name and address within 3 days after adopting "the pet."
- The "new owner" will regularly send videos and photos of "the pet," and also whenever the "previous owner" requests them.
- The "previous owner" may always visit "the pet" after prior arrangement.
- The "new owner" will also regularly inform the "previous owner" about how "the pet" is doing. This is to monitor "the pet" and ensure he/she is doing well.

If – for any reason – "the pet" needs a new family, I, the "previous owner," will place "the pet" again on a rehoming and adoption website, and he/she will stay with the "new owner" until the "previous owner" finds the right family for adoption. The new family must sign the same contract and provide their address and ID or passport number to the "previous owner."

By signing, the recipient agrees to the following points:

- The animal may never be placed in a shelter.
- To keep and care for the animal in accordance with the Law and Animal Welfare regulations.

- To refrain from any abuse or mistreatment and to ensure all necessary veterinary care is provided immediately.
- The recipient has been informed of any illness or pregnancy of the animal and commits to contacting a veterinarian immediately for necessary care.
- The animal will not be used for breeding or consumption.
- The animal will be protected from abuse and/or mistreatment by third parties.
- In case of problems (e.g., biting, escaping, disobedience, other behavioral issues), the animal will not be euthanized; instead, the owner will attend training with the dog and possibly engage a behavioral specialist, always contacting the previous owner to discuss the best course of action and to report progress.
- In the case of an incurable illness, euthanasia will only be carried out by a veterinarian and only after informing the previous owner first.
- The animal will not be made available for animal testing.
- The animal will never be kept in a kennel or cage and will not be chained up.
- All necessary vaccinations and deworming treatments must be repeated regularly.
- The animal may not be passed on without the previous owner's consent. If there are serious reasons for rehoming, the owner must immediately inform the previous owner to jointly find a solution in the animal's best interest.

Written form requirement

Changes and additions to the above contract must be made in writing.

Jurisdiction

The parties agree that, in case of breach of contract, the competent court in the "previous owner's" place of residence will handle the matter.

This contract is executed in two copies and is legally binding for both parties.
